Volunteer's Release and Waiver of Liability and Indemnity Agreement

I, the undersigned volunteer ("Volunteer") of Kokomo Rescue Mission ("KRM"), in return for being allowed to participate in KRM volunteer activities and all related activities, including any activity incidental to that participation ("Volunteer Activities"), agree and understand that the purpose of this ministry is to provide Christ-centered programs and services for the homeless and those in need. The Kokomo Rescue Mission's vision is to see the homeless, hungry, and hurting achieve wholeness through its Christ-centered programs and services.

Assumption of Risk and Release of Liability:

I agree and understand that the guests served by KRM have many diverse needs and conditions, which may include mental, spiritual, emotional, physical, and social maladjustments. I, for myself, my heirs, next of kin, personal representatives and assigns, hereby release, waive, discharge, and covenant not to sue KRM and its directors, staff, and agents from all liability, loss, claims, demands, possible causes of action, court costs, attorneys' fees, and other expenses arising from any lawsuit that may otherwise accrue from any loss, damage, illness, or injury to my person or property in any way resulting from, or arising in connection with, or related to my participation as a volunteer, including anything related to KRM's own negligence.

Confidentiality:

As a volunteer of the Kokomo Rescue Mission, I understand the ethical, legal and moral responsibility to safeguard all information and records pertaining to all client/resident and donor records, and Mission strategies. This is inclusive of all case management issues, personal background information, financial records and strategic plans that are not available through public sources.

- **Client/Resident Information:** I realize it is a violation of this confidentiality agreement for me to discuss personal information revealed by clients/residents in class, group or one-on-one settings outside Kokomo Rescue Mission.
- **Donor Information:** I realize it is also a violation of this agreement for me to discuss or disclose any information about the identity of any donor and/or donor's financial contributions or personal history with the Kokomo Rescue Mission, without the donor's written permission to do so.
- **Financial Business and Strategic Planning Information:** I also understand that it is a violation of this agreement to share with any individual agent or agency, or any publisher or newspaper, information about the Kokomo Rescue Mission's business matters or financial interests that have not been made public. I understand this provision is to protect the integrity of the Kokomo Rescue Mission and its operation.

Code of Conduct:

I understand that the Kokomo Rescue Mission is a Christian organization, with the mission of ministering to those in through the authority of the gospel of Jesus Christ; therefore, I will agree to not share any different belief system to the guests at any KRM facility or event. I will conduct myself in a manner worthy of the gospel of Christ, (Philippians 1:27) always remembering every person is made in the image of God and deserves respect. (Genesis 1:27) Modest clothing is required, no offensive t-shirts. Weapons, alcohol or drugs of any kind are prohibited on the KRM property and events.

Family/Group Representative:

If representing a group, I understand I am the Family/Group Representative and by signing this waiver, whether physically or by digital verification, I am signing for all mentioned parties. I understand it is my responsibility to communicate the standards above to **all** group members and take responsibility for each group member's compliance with these standards.

Photographic Release:

I hereby grant KRM, TrueSense Marketing, DBInsights LLC, or other agents contracted by KRM not named here the absolute right and permission: to publish my (or my groups) testimony and quotes, to use any pictures, video, and images of me (or my group) in any form, to use any pictures, video, and images of the minor(s), in my group. I understand I will receive no remuneration.

I waive any right that I may have to inspect or approve the finished product or the advertising copy that may be used with the above, or the use in which it may be applied. I release, discharge, and agree to wave KRM, TrueSense, DBInsights LLC, or other agents contracted by KRM not named here from any liability because of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur in the taking of those images, or in any processing tending towards the completion of the finished product.

STATEMENT OF FAITH

THE KOKOMO RESCUE MISSION

- ◆ We hold the Bible to be God's Holy Word in its entirety and inspired in every part by the Holy Spirit (2 Timothy 3:16 2 Peter 1:21).
- ◆ We hold that man was created in the image of God, holy and innocent; that of his own choice, he sinned, and, as a result, brought death upon all humanity (Romans 3:23; 5:12; 6:23). Those who are not saved from sin are eternally separated from God (John 3:18).
- ◆ We hold that Jesus Christ is God, born of a virgin, that He gave His life on the cross where He, Who knew no sin, was made sin for us; that He was buried and arose again from the dead, afterward He ascended into Heaven, from whence He will come again (John 5:39; 2 Corinthians 5:21; 1 Corinthians 15:4; Acts 2:9-11).

- ◆ We hold that Jesus Christ is coming again for His church, to establish His kingdom on earth, to judge the wicked and the lost, cast death and hell into the Lake of Fire, and dwell with the saints forever and ever (John 14:3; Titus 1:13; 1 Thessalonians 5:16,17; Revelation 20:6; 20:14,15; 22:1-5).
- ◆ We hold that through preaching, teaching and ministering, the Kokomo Rescue Mission must use all of its resources and activities to bring men, women and children under the power of the Gospel, that they may have victory over sin, come into fellowship with God and live a Spirit-filled, fruitful life in Christ.
